SECTION VII · HEALTH AND FIRST AID

PRIMARY ROUTES OF ENTRY & EFFECTS OF OVER EXPOSURE:

Eyes: May cause slight to moderate irritation.
Skin: None known.
Inhalation: None known when used in accordance with label directions. Intentional misuse by concentrating and inhaling the contents may be harmful or fatal.
