SECTION VII · HEALTH AND FIRST AID

PRIMARY ROUTES OF ENTRY & EFFECTS OF OVER EXPOSURE:

Eyes: Direct contact may cause irritation.
Skin: Frequent or prolonged contact may cause irritation.
Inhalation: Inhalation of mist can cause irritation of nasal and respiratory passages. Frequent or prolonged exposure may cause irritation to the upper respiratory tract, coughing, dizziness, nausea, headache, and other central nervous system effects.
